To Whomsoever it may Concern

This is with reference to Corporate Insolvency Resolution Process (“**CIRP**”) of KSK Water Infrastructures Private Limited (“**Corporate Debtor**”) initiated by Hon’ble National Company Law Tribunal, Hyderabad Bench (“**Hon’ble NCLT**”), pursuant to its Order dated 1st January 2021 (Order Copy uploaded on 7th January 2021), wherein Mr. Naga Bhushan Bhagawati was appointed as the Interim Resolution Professional to manage the affairs of the Corporate Debtor in accordance with the provisions of the Insolvency and Bankruptcy Code, 2015 (“**the Code**”) and rules and regulations made thereunder.

The Committee of Creditors of Corporate Debtor in its third meeting decided that to replace the existing Interim Resolution Professional and passed a resolution for appointment of undersigned named **V.Venkatachalam**, as the Resolution Professional of the Corporate Debtor.

Subsequently, an application was filed with the Hon’ble NCLT, the Adjudicating Authority vide its Order dated 8th April 2021 (Order Copy uploaded on 16th April 2021) appointed the undersigned as the Resolution Professional.

It may be noted that in consonance with the stipulations contained in Section 23 of the Code, from the date of appointment of the Resolution Professional:

- the Resolution Professional shall conduct the entire CIRP and manage the operations of the Corporate Debtor during CIRP;
- the Resolution Professional shall exercise powers and perform duties as are vested or conferred on the Interim Resolution Professional under this chapter;

It may further be noted that in accordance with Section 23 read with Section 19 of the Code, the personnel of the corporate debtor, its promoters or any other person associated with the management of the corporate debtor shall extend all assistance and cooperation to the Resolution Professional as may be required by him in managing the affairs of the corporate debtor and where any personnel of the corporate debtor, its promoter or any other person required to assist or cooperate with the Resolution Professional does not assist or cooperate, the interim resolution professional may make an application to the Adjudicating Authority for necessary directions.
